#### **COVID Email Update 19 October 2020**

#### Good morning to you all

After a long period of no change, a definite change this week. Tier 2 restrictions for London came into force at midnight on Friday. We do not yet know for how long. Please do attend if you can.

The combination of Tier 2 restrictions, the end of the furlough scheme in 2 weeks, and the end of the eviction freeze, on top of existing stressors, is likely to impact many of the families we are working with. Please do strengthen scaffolding networks around families as much as you can, and make sure every family is connected with community supports, services and centres. It's vital that families have local sources of support they can draw on in the event of any further lockdown restrictions (actually, that's important at any time).

We have so many good friends in Camden's community organisations and they're all incredible people with huge hearts who know Camden inside out, so please do include them in your thinking about a family's support network. Updates for you this week:

#### **Individual Risk Assessments**

This week, your managers will be working with you to review your individual risk assessment, and make sure you have everything you need to work as safely as you can. This is particularly for staff who were previously shielding, who live with people who were shielding, and for Black, Asian and minority ethnic staff. This is precaution as you have all been keeping your risk assessments under constant review. But your managers will be prioritising time this week to look at this again with you. ## Additional Alternative Venues Added Including 5PS

We have now sourced an additional 8 venues that we can use for visits outside the home. This includes additional meeting rooms in 5PS (on the ground and 1<sup>st</sup> floor), Kentish Town Library, and venues that Adult and Community Learning are using and have been checked as COVID secure. This means we now have 15 community venues that can be used for visits outside the home, in addition to schools who are being as flexible as they can for you to see children or families on their sites.
