COVID Email Update 2 November 2020

Good morning to you all

A second national lockdown will start from Thursday until 2 December. We have some of the guidance we need from the Government about what lockdown will mean this time, and we await some other key information due today. I will be holding a whole service briefing on Tuesday morning where we will run through what this means for family support. Calendar invite to follow.

Although perhaps anticipated, this second national lockdown will mean temporary but significant change again for us and our own families, and for the families we help. We have some memory muscle to draw on this time. We have been through the first lockdown, learned a great deal, and we are much more prepared and ready. We have our emergency management plan, which sets out precisely how we will work. We have a strong set of policies and procedures to guide our work during a lockdown.

We have strong relationships with Camden community organisations, who will be vital to helping Camden families feel safe and strong during lockdown. Schools, nurseries, colleges and universities will remain open during this lockdown, which means they will see (most) children every day. Not all businesses will close completely this time. So this is a different lockdown to the first one.

However, any lockdown will of course bring its challenges - physically, practically and emotionally. The importance of us all looking after each other has never been stronger than it is now. It's also important we stay open to the idea of this second lockdown lasting beyond 2 December. The more open we are to the possibility, the easier it might feel to cope if it happens.

When the first lockdown started on 23 March, I wrote to you all to say we would get through it together. We've got through the last 33 weeks together and we'll get through this next chapter together. I will keep preparing us for what is to come as much as I possibly can, and I am by your side every step of the way, just as I know you will be by the side of every family you help. We are not doing this alone. We stand shoulder to shoulder with the Camden community as part of a collective effort.

Government Guidance on the Second Lockdown

People Previously Shielding - Guidance during Second Lockdown

The new Government guidance says that anyone in the previous shielding group (classed as extremely clinically vulnerable to COVID) should work from home exclusively during the second lockdown. If you were previously in the shielding group, your manager will be in touch today to talk this through with you, as we must make sure we do all we can to help keep you safe. This means you should not come into 5PS or do any face-to-face visits or meetings from at least Thursday when the second lockdown starts but I would strongly advise starting this from today.

The new Government guidance also says that anyone in the clinically vulnerable group "should be especially careful to follow the rules and minimise your contacts with others". Furlough Scheme Extended for the Second Lockdown

The Government furlough scheme that protected some jobs was due to change today. However the Government has announced that furlough will continue as it is until 2 December

Consent Form and Privacy Notice Now on the Guidebook

You must also give the family a copy of our privacy notice (you can provide either a link to our early help web page or a hard copy, both are on the Guidebook). Information Rights are having a look at information sharing consent procedures at the moment, and I will let you know if anything changes.

Tax Relief If You are Working from Home

You may have seen the Essentials email that HMRC have simplified their system to claim tax relief on working from home expenses. If you are currently working from home you can now apply to get the whole year's tax relief at £6 per week. This equates to a gain of £62 a year for a basic 20% rate taxpayer, and £124 a year for a higher 40% rate taxpayer. Rule of 6 Exemption Letter

We now have a signed letter from our Executive Director Martin Pratt that confirms family workers are exempt from the 'rule of six' when they are meeting with families for work purposes. Please make sure you either save the letter on your mobile or laptop or keep a hard copy with you when you are visiting families, just in case you are challenged on why you are meeting either in their home or if you are meeting with more than 6 people.
