COVID Email Update 15 February 2021

Good morning to you all, I hope you and your families are doing okay.

Last week, I had the pleasure of reviewing the 98 relationship feedback forms received from the start of COVID in March 2020 to 9 February 2021. There were 64 forms for family workers and 34 for early help coordinators. Your service managers have the full feedback results, and your team managers will be sharing the individual feedback with you in supervisions. Here's some headlines of what families said (I made the images on an app and 10 = good!):

You should feel so proud that families are saying that the help is still helping. This is what it's all about – compassionate relationships that help create the conditions for change, practical and emotional support that helps a family to get where they want to be.

I don't ever underestimate how hard this has been, and continues to be, for you. Having to work this way is so different; it's hard, its physically and emotionally exhausting, it doesn't work for everyone and it doesn't always feel comfortable, for us or for families. We've had to adapt so much and yet stay true to our purpose and values. But just take a moment to reflect on what families are saying. In the middle of a pandemic, the help is still helping.

Thank you. To each and every one of you, whatever job you do in this service. We are one team, everyone pulling together to make it work. Thank you.

Updates for you this week:

Visits to Families Decision-Making Tool

There is now a tool on the Guidebook to help you and your manager think about whether you should do a face-to-face visit with a family during lockdowns and Tier 4 restrictions. The tool looks at unique family circumstances, the gravity, severity and frequency of risk to the children's welfare, the risks of COVID, the best interests of the child/ren and other factors. The tool is not mandatory, but can used to help you and your manager think about your decision and your rationale about visiting families. You and your manager must casenote your decision and your rationale, whether you use the tool or not. Eviction Freeze Ends on 21 February

The Government temporary freeze on evictions ends on 21 February. This means landlords can begin processes to evict families again, and this will particularly affect families in private rented accommodation. If you are working with a family who might be affected by this, please think about how to help them get ready for this now, so we can help prevent evictions wherever possible. 
Relationship Feedback Form Links Now on the Guidebook

Weekly Survey

This week's family needs survey, for you to raise any issues you're seeing and noticing for families and anything you might need yourself, is now open here <u>FSCF FAMILY NEEDS SURVEY W/C 15 FEBRUARY 2021</u>. A couple of responses to last week's survey:

Old work phones	We can definitely get old work mobiles replaced that aren't adequate for remote working (e.g. can't download whatsapp) so please do talk with your line manager so we can get you a new one ordered asap
Schools and period poverty	This came up in a recent query from Comms, and I've followed it up with the Camden Learning Healthy Living Team who liaise with schools on period poverty – will come back to you asap.
Webinars	l'Il of course keep putting these on (one today and at least 3 more to come in the next month or so!), and l've asked the Head of Adult and Community Learning about accessing a level 2 course on infection control – will come back to you asap
Parents and social media	Social Switch did a number of webinars for Camden parents on this subject recently, I'll ask if they can do a webinar for us so we can feel confident to give, and explore, the information with parents. More to follow.
Face to face contact with	You commented quite rightly that some families (and us as well) are feeling the challenge of no
families, particularly children with additional needs and communication challenges	face-to-face contact. I'm sure you and your manager have already talked this through, but it might be worth using the 'visits to families decision-making tool' I mentioned above. As Tim said when he briefed you all when we went into third lockdown, we still have the option of face-

to-face visits if we feel that it is in the best interests of the child, and based on the gravity,
severity and frequency of risk to the children's welfare. I know these are never easy decisions
to make, so please do talk with your line manager (if you haven't already) and use the tool if it
might help with decision-making.

If you're finding juggling life and work to be overwhelming at the moment, please do talk with your line manager so we can help think through how to alleviate some pressures. As we say in our work with families, it is rare that nothing can be done.

To end this week with a short biography of Lugenia Burns Hope – an early 20th century social activist, reformer and community organiser, who worked for the improvement of Black communities through social work, community health campaigns, and political pressure for better education and womens suffrage.
