Community Safety Officers (CSOs)

Team/role

- CSO are a team of 10 officers (FTE)
- Each officer works on a 'patch' with more case-work for ASB matters on Camden's Housing estate and street properties.
- Agencies we work closely with include Police, Probation, Children's and Youth services, Adult Social Care, Housing, Parks, Community representatives, Councillors and more.

What we do

- We have a risk management lens.
- We become involved when issues are high risk or create significant community impact.
- Responses can include risk assessment, case-work, legal interventions and community meetings/ cohesion events.

What is happening – describe the ASB Where – the location, be as precise as possible

When – the frequency, days and times
Who – can you describe who is responsible
for the ASB (their appearance if you don't
know their names). Who are the victim/s.

Why - Do you know why the ASB is happening?



Community Safety interventions

We can work with partners where there is identified risk in relation to community safety, e.g. drugs, cuckoo'ing, targeted harassment, hate crime, serious youth violence and youth safety.

- In the case of issues on Camden's housing estates and street properties, this can include network meetings, home visits, legal interventions (e.g. closure orders, tenancy enforcement), locksmiths' assessments, community interventions to encourage reporting and get a better picture of what is happening.
- In the case of issues on other land-types we can support, advise, provide information about the wider locality
- High risk or ongoing issues can be stepped up to the Community MARAC for support, advice and guidance to discuss blockages and risk.
- We also hold an overview of risk, e.g. we monitor and discuss with police all known drugs address locations to assess localities where vulnerable people and communities may need more support.



Council patrolling services

- Community Presence Officers (CPOs) patrol Camden providing high visibility reassuring presence including:
- Collecting information to be used by partners internally and externally.
- Attend hotspot areas which have been reported via the HUB, gathering information from the community and responding to it.
- Supporting vulnerable clients that are in need of help.
- Engaging with young people to gather their opinions and help them sign post them to relevant agencies.

- The Responsive Security Patrol, (prev. Housing Patrol) cover Camden's Housing estate and street properties.
- They are a unit of ten officers in five cars who provide an out of hours service regarding ASB between 4pm and 4am.
- They can witness activity around criminal and ASB, intervene by sending patrols to disrupt ASB, gather evidence and report any ASB they encounter.
- Proactive patrols can be requested by Housing and Community Safety officers.

CCTV

- Camden Council has a network of around 1,000 housing and public safety CCTV cameras.
- The CCTV control room on Holmes Road can be contacted regarding whether there is a camera at a location and/or how request monitoring of existing CCTV: CCTVPatrols@camden.gov.uk
- All CCTV must also meet standards set out by the Information Commissioners'
 Office (ICO) which includes safeguards to people's reasonable expectation of
 privacy in the public realm.
- Residents and businesses can install their own CCTV providing it meets ICO standards, Camden's local planning criteria and where they have the permission of their landlord if they do not own their property.
- Community Safety have a small number of Rapidly Deployable Cameras which can be utilised with are usually used in relation to multi-agency crime prevention or safeguarding operations instigated by our service



Community MARAC

Multi-Agency Risk Assessment Conference

- The Camden Community MARAC is a multi-agency panel where information is shared on vulnerable victims of anti-social behavior (ASB) or hate crime.
- The aim is to identify the highest risk, most complex cases and problemsolve the issues of concern.
- The main focus of the panel is to manage the risk to the victim and provide options for increased safety. The panel also considers other persons affected, the behavior of any perpetrator/s and managing any impact or risk to the community as well as effective safety planning strategies.
- Regular attendees include Community Safety, Police, Victim Support,
 Camden Mental Health and Forum+
