



#### Weekly Infection Rate Map



#### Change to Camden PPE Use In Residents Homes Guidance



#### What do we know now?

- Early Help
- There has been guidance from Camden and Islington Public Health on home visits since May 2020
- On use of PPE, the previous guidance said:

Activity and setting	Circumstances in which PPE is required	What to use?
Urgent home visits including: • urgent repairs • safeguarding	PPE is required if staff must be within 2 metres of anyone in the household and: ANY household member has symptoms of COVID-19 that started in the last 10 days, or still has a fever <u>and/or</u> ANY household member is within the self-isolation period relating to a person having COVID-19 symptoms or having been identified as a close contact of someone with Covid-19 or quarantining following travel from abroad.	Fluid resistant surgical mask Disposable plastic apron Disposable gloves <u>Risk assess</u> need for eye protection i.e. likely risk of splashes, droplets or blood or body fluids.

### What do we know now?

- On 16 April 2021, Public Health guidance on use of face masks changed. It now says:
- Type IIR surgical face mask should be worn when it is not possible to maintain 2 metres social distance at all times REGARDLESS of whether there are COVID symptoms in the home or whether the household are self isolating
- It also now says that to change a Type IIR face mask in between visits to home
- Previously the guidance was that the same mask could be worn to different visits
- The guidance to call ahead (e.g. our pre-visit checklist) remains the same

#### Working in people's homes

Always call ahead of a home visit to check if there is anyone shielding or isolating at the property (see the Home Visits Guidance)

If residents fail to keep a 2m social distance despite reminders, the Council supports staff to leave the home.

Risk assess where potential hazardous substances may be encountered and ensure any additional requirements are followed.

## Why did the Guidance Change?

Public Health said:

"This is above the national minimum PPE requirements for Children's Services,

however we recognise that when working in residents' homes it can be difficult to always maintain 2 metre distance,

so have updated the guidance to advise that type IIR surgical facemask is worn in these situations to provide additional protection against any asymptomatic cases".





#### What does this mean for face-to-face visits?

- If you can't maintain 2 metres distance in either a home or alternative venues, you are advised to wear a Type IIR face mask
- You should change the Type IIR face mask before going to your next visit
- Which means.....
- You will need to have regular stock of Type IIR face masks



#### **Resources to Help**

- The FSCF PPE store is in the FIF cupboard on the 9<sup>th</sup> floor at 5PS
- There is always stock of Type IIR face masks in our store, and stock is replenished monthly
- You can collect your face masks from 5PS, and we have enough stock for you to have a months supply at a time
- In extraordinary circumstances, your line manager can post masks to your home, but that will be the exception not the rule
- We recommend you have 15 masks a month
  - this is calculated on the basis that on average, family workers have around 6-7 cases each and
  - Do 1 face-to-face visit to a family once a fortnight (e.g. our blended approach)
  - 15 masks would give you enough stock for each of those visits.
  - If you are working with more than 7 families, please collect more masks

## The most important thing we continue to think about and plan for

Making sure we continue to keep you as physically safe and well as we can

Protecting your emotional health and your emotional reserves, making sure workloads are manageable, and that you have the scaffolding you need



# Things we are currently thinking about and planning for



Third wave – Prime Minister alluded to this possibility in his briefing this week

Variants – no surge testing yet in Camden, but would need to be prepared for the possibility of new variants in the borough

Vaccination take up, amongst staff and in Camden community (as a risk mitigation factor)

Lateral flow test take-up and regularity (as a risk mitigation factor)

Continued protections for workers who were shielding, or workers who live with family members in that group, or from Black, Asian and minority ethnic groups

Use of Council buildings from 21 June onwards – what does a 'new normal' routine look like including use of 5PS

Making sure we are keeping you as safe and well as possible, not just from COVID but in following our usual risk management processes (e.g. lone working, joint first visits etc)



## A Reminder on the Change of Guidance to Positive Lateral Flow Tests



As mentioned in this weeks email bulletin, the guidance on what to do if you have a positive lateral flow test has changed.

The advice is now:

- If you take a lateral flow test, at home or at a test site, and it is positive, go for a follow up PCR test (the test for people with COVID symptoms)
- You should do this within 2 days of the positive lateral flow test
- For example if you have a positive lateral flow test on a Monday, you should take a positive PCR test by close of play Wednesday
- The guidance has changed to try and prevent unnecessary self isolating if the lateral flow test is false/positive. Also because the lateral flow test is more accurate when there is more COVID virus around and because the PCR test can identify different COVID variants which the lateral flow test can't.
- There is no legal requirement to take the follow up PCR test
