

## COVID Email Update 21 June 2021

Good afternoon to you all, I hope you and your families are all doing okay.

As expected, the Government postponed the lifting of the final stage of lockdown until 19 July, subject to review. I know this will have brought mixed emotions, all depending on our own unique family circumstances. I've agreed with our SMT that we'll continue with our bubble rota until that final stage of lockdown is lifted, and as ever we'll be guided by what Public Health tell us nearer the time.

COVID cases have risen in Camden as they have in many other parts of the country, so it's as important as ever that we stay vigilant, keep doing our pre-visit checks before we see families, and keep updating our individual risk assessments every 20 working days, to help keep you as safe and well as possible.

Cases in Camden ▾

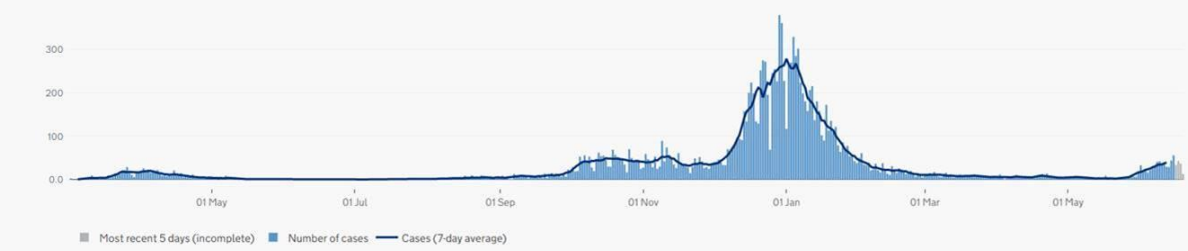
### People tested positive

### Cases by specimen date

Number of people with at least one positive COVID-19 test result, either lab-reported or rapid lateral flow test (England only), by specimen date. Positive rapid lateral flow test results can be confirmed with PCR tests taken within 72 hours. If the PCR test results are negative, these are not reported as cases. People tested positive more than once are only counted once, on the date of their first positive test. Data for the period ending 5 days before the date when the website was last updated with data for the selected area, highlighted in grey, are incomplete.

### Update on Our Racial Justice Goals

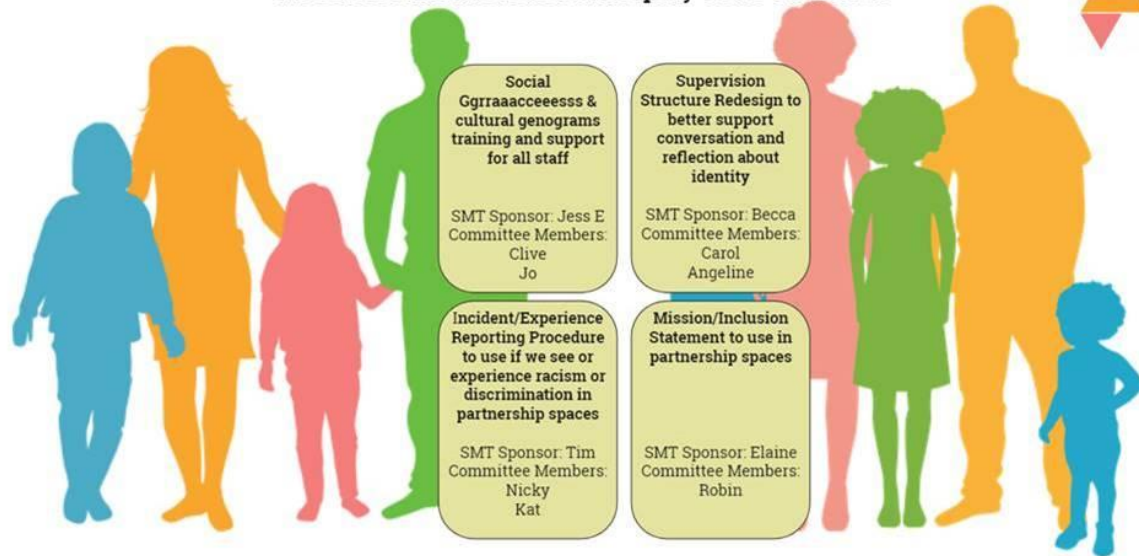
Our Racial Justice and Equity Organizing Committee met for the first time last week. We reviewed the goals submitted by EHC, FSEH, FIF and TT.

We are now in week 66 of COVID and whilst our capacity continues to hold steady, our step ups to social care and our step downs from social care have increased in recent weeks. Both impact our work in lots of ways but particularly reflect the complexity you're all holding at the moment, which also speaks to the complexity that the families we're helping are holding too. I'm really conscious of this and I'm making sure Eve and Martin are aware of it too. We're also keeping a really close eye on thresholds, with lots of joint audits with children's social care.

We'll do all we can, in every space we have, to support you and hold you in the work – your own supervision time is so important so you can unpack the work you're doing and how it's feeling for you.
