### COVID Email Update 2 August 2021 (dyslexia friendly version)

Good afternoon to you all, I hope you and your families are all doing okay.

It is exactly a year to the day that we returned to full face to face work after the first lockdown in 2020. At key 'anniversary' moments like this, it feels really important to reflect the journey taken, the challenges we've faced and continue to face, personally and professionally, what's got us through the difficult moments, and what we might need now and into the future. We've said so often in the last 18 months that resilience is never a solo effort – so as ever, please do reach out if you feel you need a helping hand.

Updates for you this week:

#### **Home Office COVID Hotels**

Many of you are now working with families who are staying in one of the Home Office COVID contingency hotels for migrant families seeking sanctuary during the pandemic. There is now a fifth hotel in Camden, and the number of children staying in those hotels is higher than at any point since they first opened in June 2020. I am part of the Camden Oversight Group that is supporting work in the hotels, so if you feel stuck or need advice please do contact me and I'll do my very best to help or find someone who can.

#### **Ofsted Preparation**

I wanted to give you some headlines about preparations taking place for an Ofsted inspection. Camden Childrens Services last had a full inspection in 2017. Its widely expected that we'll have another full inspection in the autumn. This could be as early as September, but we won't know until the day we get the call from Ofsted. We also had an inspection 'focussed visit' in 2018, where Ofsted looked at how we help children in need of help and protection (front door, early help, CIN and

Having been through seven of these inspections over the years, their overall purpose always feels two-fold:

- To check we are helping children and families to the very best of our abilities and are making a difference to their lives
- To check we know ourselves well, that we're self-aware and are doing things to make our help even better

Ofsted have a list of things they look at, which they use to judge how we're doing. There is lots of work going on to prepare for inspection. The Director of Childrens Safeguarding and Social Work Rashida Baig and our Director Eve Stickler are jointly leading that work. All children's services departments participate in this preparation, from front door through to Looked After Children.

There will be more comms about the inspection coming soon, including some guidance to help you prepare for a conversation with the inspectors if they select one of your pieces of work to look at. But the most important thing to focus on, always, is the families we're helping. Camden families really are what matters most, above all else.

#### Parking Extensions - Update

You'll remember that the extended parking permits for staff ended on 30 July. We have asked Parking Operations if we could extend some permits for staff where we felt their risk assessment needed the added mitigation of a parking permit. Regrettably our requests were turned down, but we felt strongly that this needed to be considered further, so we have asked Eve to raise it with Martin's DMT. I will of course keep you posted on any progress.
