# **COVID Email Update 13 September 2021**

Good morning to you all, I hope you and your families are doing okay.

I'm so sorry there has been a 2-week delay since my last weekly bulletin. The reason has been the Afghanistan crisis response and I've set out more about this below.

### **Afghanistan Crisis Response**

You may have seen in the news that following the evacuation from Afghanistan, there are hundreds of refugees staying in temporary accommodation hotels in London. This includes a significant number of children. The hotels have been opened by the Home Office as somewhere for the refugees to stay until longer-term resettlement accommodation is available across the UK. These temporary accommodation hotels are known as bridging hotels, and some are in Camden.

Family Early Help has been part of the crisis response since the first day that Afghan refugees began to arrive in our borough just over 2 weeks ago. We've just completed our 3<sup>rd</sup> weekend oncall working alongside emergency management, temporary accommodation staff, the hotel staff, NHS and local community groups to get essential items to children and families so their basic material needs are met. We are also part of the emergency command structure that has been put in place to manage the crisis response.

I cannot tell you how many times I have felt an incredible pride for the way our Camden community and its organisations has responded to this crisis. Camden has proved yet again that this is a place where help is for everyone who needs it, from anyone who wants to give it.

I will put a whole service briefing in your calendars for later this week so I can tell you more about the situation and the ways it might affect family support work. There are some unique circumstances for the Afghan refugees in the bridging hotels that are very different to residents in the other Home Office contingency hotels. If you find yourself working with a family staying in any of the Home Office hotels, please contact me so I can help and link you into the wider response. I will also put a new section on the Afghanistan crisis response on the Guidebook later this week.

As ever, whether a child calls Camden home for 7 days or 17 years, we will love them and do our very best for them so they can feel they are living safe and well. The reality of that is often very complicated, but the principle is not. I have complete confidence that value will be upheld in our work with Afghan refugee families, who have experienced so much trauma already.

### Return to School – COVID

### Ofsted Preparation - Update

Thanks to everyone who was able to come at short notice to the briefing sessions on preparing for an Ofsted inspection. If you weren't able to make it, the slide pack is attached, so please have a look through. We'll be sending round more information about inspection, including Top Tips for Meeting with Inspectors, later this week and there will be lots of opportunity to discuss it in your team meetings.

Whilst there is lots of activity going on to get ready for an Ofsted inspection, my ask of you is simply to keep your focus exactly where it needs to be – on the children and families we help and the work you do with them. We exist to serve Camden children and families and that's what matters most, all the time.

### **Updated Stepdown Protocol**

Our process for receiving step downs from social care has been updated. This reflects learning from recent audits about what's working and what could be better. Please do take a few minutes to read the refreshed protocol and talk with your manager if you have any questions about it. Many of you know I have a bit of an allergic reaction to the term 'step down' because I'm not a fan of labels (they're not a helpful or respectful way to refer to families, and I don't imagine any of us would ever wish to be referred to as 'a stepdown'). Step down really means who is going to help this family on the next part of their journey to feeling stronger, and doing it in a helpful, timely and dignified way. Hold that in mind as you read the protocol!

#### **Data Breaches**

There have been a couple of data breaches in the service recently, where confidential information has been shared with people who didn't need it.
