

## COVID Email Update 1 November 2021 (dyslexia friendly version)

Good evening to you all, I hope you and your families are doing okay. Updates for you this week:

### Bubble Rotas Now Paused

In my email update of 27 September 2021, I set out that I would be looking again at our bubble rota in light of Corporate's decision to lift social distancing at 5PS. After listening carefully to feedback from your service managers following discussions in your teams, and reviewing my service risk assessment, I have decided to pause our bubble rotas with immediate effect.

Pausing the bubble rotas means you can come and go from 5PS as you need to, and plan your visits schedule according to what works best for you and the families you are helping. For front door staff, this means you are able to come into 5PS any day of any week, and seating is available for you on the 9<sup>th</sup> floor with MASH colleagues.

My rationale for this is that in addition to social distancing restrictions lifting at 5PS, we now have enough seats to accommodate everyone in our service which we didn't before. We've also returned to '*face-to-face visits as standard except in extraordinary or exceptional circumstances*' which means limiting your movements in and around Camden to bubble weeks feels unworkable.

However, we must continue to carry out all our mitigating safety measures including doing the pre-visit COVID checklist before every home visit, keeping our individual risk assessments updated and reviewed every 20 working days, following Public Health home visits guidance, and travelling off peak wherever possible

I will of course keep this under constant review as we move into the winter so that if we do need to revert back to our bubble rotas, we'll be ready for it. I know this is another change which may feel unsettling. Please do talk with your line manager if you feel anxious or worried, we'll do everything we can to support you.

## Flu Vaccine

In addition to the national flu vaccination programme, Camden provides a number of free flu vaccines for staff. These are prioritised for frontline health and social care workers who **are not** eligible for vaccination via the NHS and will be allocated on a first come, first served basis. ## Public Health PPE Guidance Updated

You may have seen from Essentials that Camden and Islington Public Health have updated their PPE guidance for staff working in resident's homes. The one change for us is:

- When working in residents homes, staff should change their Type IIR facemask in between visiting different homes. The previous guidance allowed the same mask to be worn across visits to multiple properties.

Please do make sure you have sufficient stock of Type IIR face masks to be able to change your masks between visits. There is stock in our PPE store (in the FIF cupboard on the 9<sup>th</sup> floor at 5PS). Stock is checked once a fortnight, but if you can't find what you need please let me know.

The Government also updated its guidance for working in peoples homes on 4 October 2021. Frontline is a two-year intensive social work training course leading to a social work qualification. CSSW is about to launch Frontline in Camden for the 2022 cohort and the opportunity to apply is available for family workers. With Frontline, you would become a student for a year, and would be employed as a newly qualified social worker in year 2.
