# CQC Assurance Staff Briefing – February 2024

### **Progress Update**

There have now been 17 authorities announced across 3 waves of CQC notifications since December, including 5 in London within Northwest London Integrated Care Board patch. It seems that notifications are being made on a monthly basis, however we have continued our preparations at Camden to ensure we are ready when we are

informed of the CQC inspection.

In December, CQC issued a more detailed guide about the information request that we need to submit as part of the



assessment process. We've been preparing this information in advance. Practitioner colleagues have been reviewing and quality assessing the data we have collected so far. Following this, we will identify what evidence may need to be enhanced or address any gaps if necessary.

Alongside the work on the information return, we have continued to develop our assessment of ourselves and how we deliver our Care Act duties. This is leading to further clarity on our areas of focus. This will be shared though staff workshops on each of the four CQC themes. These workshops will further support our refining of the assessment and action planning on an iterative basis.

## **Focus Groups:**

In March, I will be hosting 2 in-person Staff Forum focus groups with frontline staff. These groups will allow us to consider with staff what they are most proud of and would want to amplify during an inspection.

#### **Good Practice Nominations**

- Transitions: ie; looked after children, young people with disabilities and young carers supported with preparing for adulthood.
- Seldom Hard people: Groups who are less likely to be represented i.e; No Recourse to Public Funds, Ethnic Minorities, LGBTQ+ and Disabilities.
- Multiple disadvantage: Groups experiencing overlapping problems simultaneously such as Mental health, homelessness, and substance misuse.

We are creating a Microsoft form for practitioners to use when submitting their nominations. This form will make it easier for practitioners to submit the information that is required for a nomination. Margaretha and Lorna will be in touch to share the form once it's created.
